NOTICE OF PUBLIC STATEMENT HEARING
UNITED WATER NEW YORK, INC. - WATER SERVICE
CASE 09-W-0731

The New York Public Service Commission will hold a public statement hearing concerning a proposal by United Water New York, Inc. to increase water service rates. The Company has proposed to increase annual base revenue by \$17.8 million (31.2%). Taking into account existing surcharge amounts, customer bills would increase by \$14.4 million (23.9%). The Commission may grant, deny or modify any portion of the Company's rate proposal. A public statement hearing will be held as follows:

The public will have an opportunity to present their statements and comments about the water company and the proposed rate increase at the hearing before the Administrative Law Judge assigned by the Commission to this case. To speak at the hearing, it is not necessary to make an appointment in advance or present written material. Persons will be called to speak after completing a request card. All comments at the hearings will be transcribed and become part of the Commission's formal record. The hearing session will remain open and continue for those wishing to speak, or other reasonable arrangements will be made in the event of numerous speakers. The public may also participate in the hearing by telephoning (845) 357-5100 or by viewing the broadcast of the hearing at the Town's internet site www.ramapo.org. The hearing will also be broadcast on the Town's Cablevision and Verizon systems.
