

NOTICE OF ANNUAL ELECTION
SOUTH SPRING VALLEY FIRE DISTRICT

PLEASE TAKE NOTICE that the Annual Election of the South Spring Valley Fire District will take place on December 13 2016, between the hours of 6:00 P.M. and 9:00 P.M. at the firehouse known as South Spring Valley (Hugh Gassner) Firehouse located at 26 Red Schoolhouse Road, Chestnut Ridge, New York for the following purposes:

To elect one (1) Fire District Commissioner for a five (5) year term commencing January 1, 2017 and ending December 31, 2021;

To elect one (1) Fire District Treasurer for a three (3) year term commencing January 1, 2017 and ending December 31, 2019; and

To vote of the following proposition:

“SHALL THE RESOLUTION OF THE BOARD OF FIRE COMMISSIONERS OF THE SOUTH SPRING VALLEY FIRE DISTRICT, ADOPTED AUGUST 23, 2016 AUTHORIZING THE AMENDMENT OF THE SOUTH SPRING VALLEY FIRE DISTRICT SERVICE AWARD PROGRAM TO REDUCE THE ELIGIBILITY AGE OF ACTIVE VOLUNTEER FIREFIGHTERS FROM AGE SEVENTEEN (17) TO AGE SIXTEEN (16); STATING THE TOTAL CALENDAR YEAR 2017 AND FUTURE YEARLY ADDITIONAL COSTS OF FUNDING THE SOUTH SPRING VALLEY FIRE DISTRICT SERVICE AWARD PROGRAM FOR CURRENT FIREFIGHTERS AS AMENDED IS ESTIMATED TO BE A ZERO (\$0.00) DOLLAR INCREASE; STATING THE ADMINISTRATION COSTS IS ESTIMATED TO INCREASE BY APPROXIMATELY SEVENTEEN AND ZERO CENTS (\$17.00) DOLLARS A YEAR PER ELIGIBLE PARTICIPANT; AUTHORIZING SUCH AMENDMENT TO BE EFFECTIVE JANUARY 1, 2017 APPROPRIATING SAID AMOUNTS THEREFOR AND STATING THAT THE FAILURE OF THE AMENDMENT TO BE APPROVED BY THE VOTERS OF THE SOUTH SPRING VALLEY FIRE DISTRICT WILL IN NO WAY EFFECT THE PROVISIONS OF THE SERVICE AWARD PROGRAM PRESENTLY IN EFFECT.”

Be approved?

All residents of the South Spring Valley Fire District, who are duly registered to vote with the Rockland County Board of Elections on or before November 21, 2016 shall be entitled to vote at this election.

Any person desiring to have his or her name appear on the ballot for one of the above offices must have filed a written request, specifying the office for which the name should appear, with the Secretary of the Fire District not later than November 23, 2016.
