## EXAMPLES-HOW TO FIGURE REDUCTIONS OR TAXES

### SCARS: ASSESSMENT REDUCED BY 4,500:

4.5 x 124.666863 = 561.00 taken off current school bill

4.5 x 107.60 = 484.20 taken off current town/county bill

**Total estimated Savings 1,045.20**

**New Assessment due to subdivision OR new construction = 65,400**

65.4 x 203.203882 = 13,289.51 school tax w/o exemption

65.4 x 107.60 + unit charge = 7037.04 Tn/Cty tax w/o exemptions w/sewer

**TOTAL ESTIMATED TAXES \$19,343.50 (DOESN'T INCLUDE VILLAGE TAX)**
