SEQR Negative Declaration Local Law – Planned Unit Development District Regulations Outside of the Northeast Area of The Town

WHEREAS: The Town Board is considering the adoption of a local law titled “Planned Unit Development District Regulations Outside Of The Northeast Area Of The Town,” which local law would enact regulations that authorize the Town Board to designate eligible properties outside of the Northeast area of the Town as a Planned Unit Development (PUD) District. Tracts of land containing ten (10) contiguous acres in the Town and under common ownership or control, on and after May 31, 2025, and upon application for a PUD designation, and with access to a public road, are eligible for a PUD District designation. Lands adjoining a PUD-eligible tract of land may be merged with that tract to create a larger PUD District, subject to approval by the Town Board. The Town Board possesses complete discretion whether or not to designate a particular tract as a PUD District and if the Board does approve a PUD District, the Board possesses complete discretion to impose requirements and conditions pertaining to the development of the PUD, including but not limited to the permitted uses, area and bulk requirements, and other requirements and conditions to mitigate potential community and environmental impacts.

In making this SEQR determination, the Board has considered the criteria set forth in §617.7(c) of the SEQR Regulations and analyzed relevant areas of potential environmental concern to determine whether this action may have a significant adverse impact on the environment. The Board has reviewed the local law, the Full Environmental Assessment Form (FEAF) Part 1 and reviewed and hereby adopts Part 2 of the FEAF, both prepared by the Town’s professional consulting engineer MJ Engineering, Architecture, Landscape Architecture and Land Surveying, P.C., and the Board has considered the recommendations and comments of other agencies and the public. Although a FEAF is not required since this is a SEQR Unlisted action, the Board prepared and reviewed the FEAF.

Title of Action: Local Law - Planned Unit Development District Regulations Outside Of The Northeast Area Of The Town

SEQR Status: Unlisted

Project Location: Town-wide, except the local law is not applicable in the Northeast area of the Town

Description of Action: See above and the legislative purpose (Section 3) of the local law (incorporated herein)

Reasons Supporting This Determination: Since this local law does not change the zoning requirements applicable to any property in the Town, this local law will not have any impact, much less a significant adverse impact, on the environment. There will be no adverse impact on any environmental issue, including the criteria for determining significance set forth in §617.7(c) of the SEQR Regulations. There are no pending petitions or applications seeking a PUD District designation pursuant to this local law. A future PUD District may be designated by the Town Board only after completion of a zoning amendment process, including compliance with the applicable requirements of this local law, and compliance with SEQR with respect to the particular PUD District designation. The Town Board possesses complete discretion whether or not to approve a PUD District. Therefore, there are no reasonably related long-term, short-term, direct, indirect or cumulative impacts which are included in any long-range plan, likely to be undertaken as a result of this action, or dependent on this action. There is no segmentation of SEQR review.

THEREFORE, IT IS RESOLVED, on a **ROLL CALL VOTE**, for the reasons set forth above, that the Board finds and determines that adoption of this local law will not have any significant adverse impact on the environment. Accordingly, this SEQR Negative Declaration is hereby issued and shall be filed in accordance with the SEQR Regulations.

This Negative Declaration was prepared in accordance with Article 8 of the state Environmental Conservation Law.

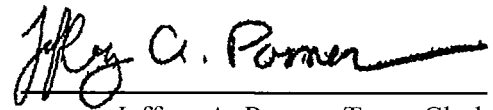

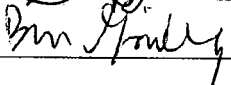

The action is adoption of the proposed local law. The Town Board previously authorized the establishment of Planned Unit Development Districts (PUD) in the Northeast area of the Town and has determined that authorizing the potential establishment of PUD Districts throughout the Town is in the public interest. Pursuant to the authority under state Town Law §261(c), it is the purpose and intent of this local law to enact regulations for the implementation of a PUD floating zone to encourage creative residential, commercial or mixed use development, including the construction of smaller and more affordable apartments and single-family detached residences. The intent of this local law is to minimize the negative impacts associated with suburban sprawl as noted in the Town's Comprehensive Plan (2004 as amended). Planned Unit Development is intended to allow flexibility in planning and designing land development proposals. This local law shall not apply in the Northeast area of the Town, where PUDs are regulated by the provisions in §376-24. This local law shall apply throughout the remainder of the Town.

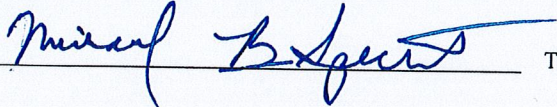
